**District Councillors Report:**

Cllr Whitehead spoke about planning issues, grants and anti-social behaviour in the Wycombe district in general. Street wardens are being appointed to curb this problem, which is maybe not as prevalent in Turville parish but certainly in other areas of the district. He has a small amount of money as a ward budget allocated via WDC, if there are any good causes that you feel may benefit please contact him to discuss. Cllr Whitehead was part of a group who successfully managed to get the proposed Lightsfest being held at Mill End cancelled, which would have been a festival that involved setting off lit lanterns into the sky during harvest season. There have been several planning issues in the parish and the wider area, which he has been involved in. Please contact Cllr Whitehead directly with any concerns you may have within the parish, he is keen to help with any issues. Cllr Whitehead will be retiring after his current term ends.

**Thames Valley Police Report:**

Sgt Hughes discussed that Turville parish is a low crime area, but that does not mean that the police rest of their laurels! A new PCSO has been appointed this week, and another PCSO has been promoted to PC, this position will be filled in due course. Sgt Hughes has taken over the Princes Risborough area now also so is split between there

and Marlow South West Rural. The best way to get hold of the Neighbourhood Policing Team is the generic email inbox:

which should be used for non-emergency matters only. There is a web form that can be used too on the Thames Valley website also to report matters, although 999 should always be used in an emergency. Sgt Hughes will supply some parking signs to stress the importance of leaving room for emergency vehicles to pass to the Bull and Butcher, Turville. Cllr Sants queried the use of bicycles on public footpaths, particularly by the windmill in Turville. The authority to prohibit cycling rests with the land owner of the footpath, the police can issue tickets if the landowner complains and does not allow cycling. Bikes should not be used on designated footpaths. Clerk will organise for some "no cycling" signs to be sent to Cllr Sants.
