- A resident asked about removing the earth from outside Murrage Farm after the undergrounding of cables. Clerk will contact the Streetworks Inspector to chase. This was meant to have been carried out last week. TfB told the contractors that they had to repair the damage done to the road.

- A resident attended to lodge their objection to planning applications 21/06762/FUL, 21/06763/LBC replacement entrance gates at The Old Vicarage & Old Rectory Cottage Turville Valley Road Turville. This was discussed during Planning item.

Minute 21/22.24

Items to note

- Clerk has reported various potholes around the parish to Transport for Bucks via <u>Fix My</u> <u>Street</u> which is an online service that anyone can use.
- There is a vacancy on the parish council, the notice of vacancy has been advertised. If no election is called by residents, then co-option procedure will commence.
- The parish council office will be closed from Friday 30th July for a week.
- Clerk has ordered pads for the AED at Northend. Cllr Nuttgens monitors this, but is finding it difficult to do so will ask for a volunteer who lives in Northend.
- The noticeboards at Southend and Turville need repairing. Cllr Nuttgens thinks that new noticeboards will be needed, she is waiting for a quotation for new boards. Cllr Wessels will also obtain a quotation from a local carpenter.

- A Turville resident has complained about the cutting of the village green, it often looks untidy and could do with a more regular cut. They have spoken with a local gardener who is prepared to strim the edges around the stones and mow it, for £30 a time fortnightly. This contractor already cuts the grass outside of the nursery in School Lane. All in agreement.

Minute 21/22.25 Superfast Broadband

An update to be provided if available from Cllr Sants (and any other Councillor as appropriate) to include an update about the work of the Turville Broadband Action Group. An update was given during item the introduction from the Buckinghamshire Councillors. Cllr Mark Turner has been liaising with Cllr Sants, regarding discussions with BT Openreach to improve broadband in the parish. BT Openreach have not come back to Cllr Turner with an up to date quotation to put forward to the parish as of yet. It is likely that whatever the Government financial support is, it will be less than the actual cost; residents could be asked to make up the difference.

The Community Infrastructure Levy money currently stands at £2440.83. £1417.95 remains in in the earmarked funding for the pond project in Northend. Other CIL money has been used for repairs benches at Churchfield Wood and Southend Bridleway. The PC to discuss if any other projects have been identified to spend CIL funds on. There are restrictions as to what CIL money can be spent on, namely infrastructure needs in the parish. Clerk to speak with Northend residents to see if any further works are needed at the pond or if the reserved money can be released back into the general CIL reserve, likely to be used for the purchase and installation of new benches.

21/06633/FUL – The Old Vicarage & St Mary's Church Turville Valley Road Turville – Erection of new metal railings and timber gate to western boundary of churchyard together with railing reinstatement work to churchyard northern boundary and insertion of gate and piers to north of the Old Vicarage – **objection.** The parish council object to this application, and would like to see the railings re-instated as they currently are. A height of 1.5metres between the Church and the Old Vicarage seems excessive for a rural setting next to a churchyard within a Conservation Area in the AONB. To keep railing that are all identical at the original height would be a more reasonable solution, particularly as there is a hedge there if there are safety concerns.

21/06634/LBC - The Old Vicarage & St Mary's Church Turville Valley Road

Turville – Listed building application for erection of new metal railings and timber gate to western boundary of churchyard together with railing reinstatement work to churchyard northern boundary and insertion of gate and piers to north of the Old Vicarage – **objection**. The parish council object to this application, and would like to see the railings re-instated as they currently are. A height of 1.5metres between the Church and the Old Vicarage seems excessive for a rural setting next to a churchyard within a Conservation Area in the AONB. To keep railing that are all identical at the original height would be a more reasonable solution, particularly as there is a hedge there if there are safety concerns.

- Cllr Sants raised a shepherds hut at the Old Vicarage, Turville which does not have planning permission. It is in the farming curtilage in the AONB and appears to be a permanent structure. Clerk to report to Planning Enforcement.
