To discuss Bull and Butcher public house, Turville and the decision by Brakspear to not carry out the works as permitted by Buckinghamshire Council in 2023

It was resolved to write again to Brakspear that there is support for the renovations to the pub from the village, whilst some aspects of the application such as the bi-fold doors were not desired. There were no material objections raised at the meeting; therefore we would like to re-iterate the desire to modernise the kitchen and a general refurbishment to ensure the longevity of the pub.

Whilst the Parish Council mow this piece of grass, it is not PC land, and therefore the PC are unable to make any decisions. Red Kite Housing have been approached for permission. The applicant was advised to speak with residents in Square Close and School Lane, as the PC would not want to endorse anything without clear evidence of widespread support from them. Concerns were raised regarding additional traffic in School Lane, and residents' driveways being used for turning.
