18/07636/FUL – Pond House Northend Road Northend – householder application for installation of new oil tank to replace existing in a different position and replace existing gates with hazel panels – PC commented no objection

18/07559/LBC – Summer Cottage and Heathclose Cottage Drovers Lane Turville Heath – internal alterations to create openings between both cottages, insertion of new timber rear door and new timber framed rear window, insertion of 2 x rooflights to rear, removal of front flint garden wall and associated works – PC commented no objection
